An Act to provide for a minimum percentage of Irish language works in radio music programming, and for that purpose to amend the Broadcasting Act 2009, and to provide for related matters. 5

Be it enacted by the Oireachtas as follows:

Amendment of Broadcasting Act 2009

1. The Broadcasting Act 2009 is amended by the insertion after section 65 of the following section: 10

“Irish language quota for programmes with musical content

65A. (1) It is a condition for the award of a sound broadcasting contract under section 65(8) that at least 5 per cent of the aggregate amount of transmission time allocated to music content, in the programmes to be provided for under the contract, shall be reserved for musical compositions containing the Irish language in the form of lyrics. 15

(2) The Minister shall—

(a) not later than 3 years after this section comes into operation, commence a review of the operation of this section, to include consideration of increasing the percentage requirement of Irish language content referred to in subsection (1); and 20

(b) not later than 12 months after its commencement, make a report to each House of the Oireachtas of the findings made and of the conclusions drawn from those findings.”. 25

Short title, collective citation and commencement

2. (1) This Act may be cited as the Broadcasting (Amendment) Act 2018.

(2) This Act shall come into operation on enactment.

(3) This Act and the Broadcasting Act 2009 may be cited together as the Broadcasting Acts 2009 and 2018 and shall be construed together as one Act. 30

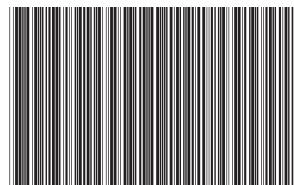
